



COVID-19 Liability Release Waiver and Assumption of Risk and Alcohol Responsibility Acknowledgement

The individual named below (referred to as “I” or “me”) desires to attend that certain event or function identified as “AZCREW Events” (the “**Activity**”) hosted by Arizona Commercial Real Estate Women, Inc. a/k/a AZCREW (“**AZCREW**”). As consideration for being permitted by AZCREW to engage in the Activity, I agree to all the terms and conditions set forth in this agreement (this “**Agreement**”).

1. The individual named below (referred to as “I” or “me”) is aware of the highly contagious nature of the 2019 novel coronavirus disease (COVID-19) (the “**Disease**”) and the risk that I may be exposed to or contract the Disease or other infectious diseases by engaging in the Activity. I understand and acknowledge that such exposure or infection may result in serious illness, personal injury, permanent disability, or death. I acknowledge that this risk may result from or be compounded by the actions, omissions, or negligence of others, including the AZCREW employees or volunteers. I understand that while AZCREW has implemented preventative measures to reduce the spread of the Disease, AZCREW cannot guarantee that I will not become infected with the Disease or other infectious diseases while on the premises where the Activity is being conducted (the “**Premises**”) and that being on the Premises may increase my risk of contracting the Disease. NOTWITHSTANDING THE RISKS ASSOCIATED WITH THE DISEASE, I ACKNOWLEDGE THAT I AM VOLUNTARILY ENTERING THE PREMISES TO ENGAGE IN THE ACTIVITY WITH KNOWLEDGE OF THE DANGER INVOLVED.
2. I hereby expressly waive and release any and all claims, now known or hereafter known, against AZCREW, and its officers, directors, employees, volunteers, agents, affiliates, members, successors, and assigns (collectively, “**Releasees**”), on account of injury, illness, disability, or death arising out of or attributable to my being on the Premises or engaging in the Activity and being exposed to or contracting the Disease, whether arising out of the negligence of AZCREW or any of the Releasees or otherwise. I covenant not to make or bring any such claim against AZCREW or any of the other Releasees, and forever release and discharge AZCREW and all other Releasees from liability under such claims. I shall defend, indemnify, and hold harmless AZCREW and all other Releasees against any and all losses, claims, damages, liabilities or expenses or costs of any kind (including attorneys’ fees) arising out of or resulting from any claim of a third party related to the Disease due to my engaging in the Activity or being on the Premises.
3. I am familiar with federal, state, and local laws, orders, directives, and guidelines related to the Disease, including the Centers for Disease Control and Prevention (CDC) guidance on the Disease. I will use best efforts to follow this guidance and follow all instructions of AZCREW while on the Premises.
4. I attest that the following statements are true upon entering the Premises:
 - o (a) I have not traveled internationally within 14 days of the date of the Activity;
 - o (b) I do not believe that I have been exposed to a person with a confirmed or suspected case of COVID-19;
 - o (c) I am not currently awaiting test results from a recently administered COVID-19 test;
 - o (d) I have not been diagnosed with COVID-19 and not yet cleared as noncontagious by state or local public health authorities; and

- (e) I am not experiencing symptoms of the Disease (such as cough, shortness of breath, or fever).

THIS DOCUMENT HAS LEGAL CONSEQUENCES. IF YOU DO NOT UNDERSTAND IT, CONSULT YOUR ATTORNEY. BY AGREEING, I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE AZCREW.
